1. Fixed Interest Rate

NCDs shall earn interest @16.5% p.a. The Company at its option,

- (a) for initial period of 30(Thirty) months from the date of allotment pay minimum interest @ 12.5% p.a and elect to have the remaining unpaid interest of 4% p.a. accrue and compounded monthly and added to the principal balance at the end of each month from 1st month to 30th month; and
