Covenants**

- a) The Company shall, at all times till the Final Settlement Date, ensure that the FACR of at least 1.0 (One Decimal Point Zero) times is maintained.
- b) The Company shall ensure that, at all times until the Final Settlement Date, the Asset Utilisation Factor is not lower than 0.7 (Zero Decimal Point Seven).

For the purposes of this term sheet the following terms shall have meanings set out below:

**"Fixed Assets Coverage Ratio" or "FACR"** shall mean the ratio of (a) to (b) below:

- (a) Gross Fixed Assets of the Company,
- (b) Total Borrowings – Total cash / bank balance (including term deposits, marketable securities placed as cash collateral) – Firm Capital Commitments

**"Asset Utilisation Factor"** shall mean the ratio of (a) to (b) below:

- (a) Gross Rentable Fixed Assets Rented Out;
- (b) Gross Rentable Fixed Assets;

**"Gross Fixed Assets"** shall mean the aggregate value of the Fixed Assets (computed on the basis of the book value thereof) of the Company

**"Gross Rentable Fixed Assets"** shall mean the aggregate value of the Rentable Fixed Assets (computed on the basis of the book value thereof) of the Company;

**"Gross Rentable Fixed Assets Rented Out"** shall mean the aggregate value of the Gross Rentable Fixed Assets which have been rented out by the Company;

**"Firm Capital Commitment"** shall mean a commitment evinced by a term sheet(s) or definitive documents entered into between the founders of the Company, the Company and the existing or new private equity investor(s) to infuse funds into the Company in the form of equity shares and/or compulsorily convertible preference shares within 90 (Ninety) days from the date of execution of such term sheet/ definitive document;



The Company shall not avail any further financial indebtedness (excluding the Above) without obtaining the prior written consent of the Debenture Trustee (acting on the instructions of the Majority Debenture Holders). It is clarified that any instrument issued by the Company which provides to the holder the right to receive coupon/ interest shall be treated as financial indebtedness for the purposes of this provision, irrespective of whether such instrument is optionally or compulsorily convertible into equity shares of the Company.</p> <p>(b) The Company shall remain the registered owner of the "Furlenco" trademark till the Final Settlement Date and shall ensure that the trademark is not encumbered or otherwise dealt with.
